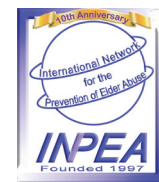
### CALL FOR POSTERS

# WORLD ELDER ABUSE AWARENESS day 2008

Building Knowledge & Networks

Abuse and neglect of older persons occurs in all countries. It knows no borders or boundaries; no country or culture is immune. As population aging takes place around the world, the number of older victims of abuse and neglect will increase dramatically unless steps are taken now to prevent its occurrence.

### *The Focus of this Conference is on Solutions.*

Day one begins with a description of some innovative approaches in services, policies, and programs in the host country, Canada. Like several other parts of the world, Canada has come far in the 30 years since this human rights issue first became recognized, but considerable work remains to be done before eradication of harms to older persons becomes a reality. Discussion of the Canadian experience sets the stage for consideration of activities in other countries.

To mark World Elder Abuse Awareness Day INPEA's official global event will take place on the afternoon of June 16th. Representatives of the consular corps will be invited to join conference delegates in learning about the status of implementation of recommendations contained in the United Nations' Madrid International Plan of Action on Aging 2002. Attention will be drawn to the special concerns of developing countries and countries in transition.

Day two opens with consideration of abuse and neglect of older persons in the context of family violence prevention, followed by a panel highlighting best practices from around the world.

The role of NGO's in advancing the abuse prevention agenda will be considered next. Delegates will then break into small groups to discuss what success would look like in addressing elder abuse and neglect on a local, regional and international scale. They will be tasked with identifying short, medium and long term goals and strategies for achieving them.

The conference will end with an outline of an action plan for the next five years, designed to advance the Madrid Plan in its goal of achieving "A World for All Ages" and a world free of abuse and neglect in later life.
